Bitfocus will present results to the committee next month.</li> <li>- Bitfocus is currently reviewing warning labels on Clarity screens for data inconsistencies. One example is if Yes is selected under Disabling Condition, but no specific type (e.g. Developmental, Physical, Chronic Health Condition) is selected, the user will see a warning.</li> <li>- BitFocus is making adaptations to Clarity to comply with 2021 HUD Data Standards by October 1.
