2021 HUD CoC NOFO Overview

- ✓ The <u>Tier 1 / Tier2 ranking approach continues</u>. Tiers are financial thresholds established by HUD in the annual NOFO based on the value of the CoC annual renewal demand (ARD) the base amount for which we are eligible to apply. The percentage is determined by HUD.
- ✓ Each <u>CoC</u> is required to rate and rank each of its projects according to locally developed criteria. HUD continues to apply its own selection criteria which include prioritizing permanent housing, as well as low barrier housing serving literally homeless households, performance, and strategic use of resources.
- ✓ <u>CoC Bonus funding is</u> available at 5% of the ARD for new Permanent Housing Projects (Permanent Supportive Housing for Chronically Homeless persons, Rapid Rehousing for all populations), HMIS, and/or Coordinated Entry.
- ✓ <u>Domestic Violence Bonus</u>: HUD is making available an additional \$102 million nationally for survivors of domestic violence (HUD Category 4). Funds can be used for new or expanded projects, and can be used for Rapid Re-Housing, Joint Component, or to help Coordinated Entry better meet the needs of those fleeing domestic violence.
