A RESOLUTION OF THE GOVERNING COMMITTEE OF THE KING COUNTY REGIONAL HOMELESSNESS AUTHORITY CONFIRMING THE IMPLEMENTATION BOARD'S RECOMMENDATION OF THE CHIEF EXECUTIVE OFFICER FOR THE AUTHORITY, AND APPROVING OTHER MATTERS RELATED THERETO.

WHEREAS, pursuant to the Interlocal Agreement for the Establishment of the King County Regional Homelessness Authority dated December 18, 2019 (the "Interlocal Agreement") between King County (the "County") and the City of Seattle ("Seattle"), the County and Seattle formed a governmental administrative agency pursuant to RCW 39.34.030(3) known as the King County Regional Homelessness Authority (the "Authority" or "KCRHA"); and

WHEREAS, under Article VIII, Section 2(j)(ix) of the Interlocal Agreement, the Implementation Board of the Authority is responsible for recommending, by resolution, a Chief Executive Officer of the Authority to be confirmed by the Governing Committee, the recruitment of whom will have been conducted jointly by the Implementation Board and the Governing Committee; and

WHEREAS, under Article VIII, Section 1(b)(ii)(3), confirmation of such recommendation requires an affirmative vote of two-thirds majority of the Governing Committee members present at the meeting; and

WHEREAS, with the assistance of The Hawkins Company, an executive recruiting firm, and the development of certain core competencies and candidate profile by the CEO Search Committee, the Authority submitted a national request for proposals ("RFP") from qualified applicants to serve in such position; and

WHEREAS, the Authority received 40 responses to the RFP and subsequently engaged in the screening, interview, meet and greet, and stakeholder engagement process; and

WHEREAS, on January 15, 2021, the Implementation Board conducted a first round of interviews and recommended finalists for the position; and

WHEREAS, the finalists participated in meet and greet events with representatives of the Lived Experience Coalition and the Sound Cities Association; and

WHEREAS, during a joint meeting held on February 3, 2021, the Implementation Board and the Governing Committee jointly interviewed the two final candidates for the position; and

WHEREAS, at its meeting held on March 10, 2021, the Implementation Board recommended, by Resolution No. 2021-03, a copy of which is attached hereto (the "Board Resolution"), to select Marc Dones for the position of Chief Executive Officer of the Authority; and

WHEREAS, the Governing Committee now finds it in the best interest of the Authority to confirm such recommendation as provided herein;

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING COMMITTEE OF THE KING COUNTY REGIONAL HOMELESSNESS AUTHORITY:

- Section 1. Confirmation of Chief Executive Officer; Budget Approval. Pursuant to the Interlocal Agreement, the Governing Committee hereby confirms the Implementation Board's recommendation to select Marc Dones for the position of Chief Executive Officer of the Authority. The Governing Committee further approves the budget and funding for such position for 2021, consistent with the salary range provided for in the Board Resolution.
- <u>Section 2</u>. <u>Ratification</u>. All actions taken pursuant to the authorization provided for in this resolution are hereby ratified and confirmed.
- <u>Section 3</u>. <u>Effective Date</u>. This resolution shall take effect and be in force from and after passage and approval.

WHEREAS, the Implementation Board now finds it in the best interest of the Authority to recommend the selection of the Chief Executive Officer and to authorize certain matters related to such position as set forth herein;

NOW, THEREFORE, BE IT RESOLVED BY THE IMPLEMENTATION BOARD OF THE KING COUNTY REGIONAL HOMELESSNESS AUTHORITY:

Recommendation of Chief Executive Officer. Pursuant to Article VIII, Section 2(j)(ix) of the Interlocal Agreement, the Implementation Board hereby recommends Marc Dones for the position of Chief Executive Officer of the Authority.

Section 2. Authorization of Employment Agreement. Subject to the Governing Committee's confirmation of this Implementation Board's recommendation set forth in Section 1 of this resolution, the Implementation Board hereby further authorizes the Co-Chairs of the Implementation Board, with assistance from The Hawkins Company, to negotiate an employment agreement (the "Agreement") with the selected Chief Executive Officer. The terms of the Chief Executive Officer's employment (including salary, effective date, benefits, and other terms and conditions) shall be as set forth in the Agreement; provided, the beginning annual salary for the Chief Executive Officer must be between \$200,000 and \$250,000, not including benefits, and the terms shall otherwise be consistent with the RFP.

Ratification. All actions taken pursuant to the authorization provided for in Section 3. this resolution are hereby ratified and confirmed.

Effective Date. This resolution shall take effect and be in force from and Section 4. after passage and approval.
