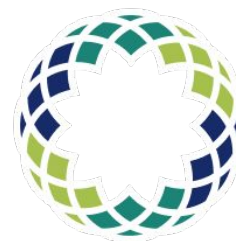

Overview

- DRAFT DUE DATE: **August 30, 2022 at 11:59pm**
 - Per HUD, you must submit to the CoC *outside of esnaps* 30 days before deadline
 - Will use this as opportunity to review and assist with any language alignment.
- DUE DATE: **September 20, 2022 at 5pm**

- Form 2880 embedded in esnaps
- Data pre-populates forms in the Project Application
- Must upload 501c.3. Code of Conduct and Supplemental SF424

FY22 CONTINUUM OF CARE (CoC) NOFO

Accessing the FY 2022 Project Application

- **Complete Part 1 -- SF 424 (Screens 1A-1F)**
 - Screen a. Application Type - Grant PIN#
 - Screen d. [Congressional District](#) - Q 17: grant start/end dates = **2023-2024**

- **Complete HUD Forms –embedded in esnaps**
 - HUD 50070 – check :”I Agree”
 - Form 2880 – Pre-populated from Applicant Profile: review and check “I agree”
 - SF-LLL - Select Yes/No to reveal additional questions then check “True and Correct”



FY22 CONTINUUM OF CARE (CoC) NOFO

The Rest of Your Project Application Appears!

- Everything is in Read Only Mode
- ***Option for “Submission without Changes”***
- Question 3A and B: Project Detail and Description
- Budget Information. No Budget Detail Required – Verify Budget Summary from GIW
- Match: if your project received a FY 2021 FMR bump; update match \$



FY22 CONTINUUM OF CARE (CoC) NOFO

Submit without Changes - Caveat:

- If any of the following apply, you **cannot use** the submit without changes process:
 - HUD placed a condition on your FY 2021 application requiring your organization to adjust information (e.g., units, unit configuration, BLIs); or
 - You executed a grant agreement amendment resulting in changes needed to the renewal project application (e.g., units, unit configuration, population served, BLIs).

You must ensure your FY 2022 renewal project application mirrors the final HUD approved information in either the grant agreement or grant agreement amendment.
