What motivates you to be on the CoC Board?

Candidate #1 - Titi White

I am extremely interested in joining the CoC Board to gain a better understanding of the processes and barriers that we, as a county are facing, in regards to federal funding/assistance. I have battled homelessness in the past, as a young mother, and my heart breaks for the families that I see and hear from, on a daily basis, who are experiencing homelessness with little to no help or guidance from the county.

Candidate #2 - Elizabeth McKeen Fitzgerald Maupin

I am particularly interested in efforts to keep people from becoming homeless and in addressing the needs of vehicle residents and unhoused couples, two groups that seem to be overlooked in many of our plans to address homelessness. I wish we might also spur our community to address the primary systemic causes of homelessness -- the high costs of housing here in King County and our low vacancy rate for housing that is affordable to those with modest to low incomes. Some of this should be addressed through changes in zoning ordinances and some through state legislation to keep rents from rising faster than minimum wage incomes. Public perceptions and political will are key to any efforts to address homelessness effectively.

My specific interest lies within the ways I live and relate within this space. I am currently homeless. I am a homeless, multiracial, LGBTQQIP2SAA+. Two-spirited, military veteran, physically, intellectually, behaviorally disabled person in recovery with adult children who are necessary for me

to live, as I need live-in caregivers. I have a severe brain injury, PTS/moral injury, depression, incomplete spinal cord injury, & accompanying disabilities from these injuries. I am working toward my master's degree with aspirations to get my law degree. I have a small business. I am motivated by the fact that I am homeless and people within our community still see homelessness as a choice. I am not choosing this. I am choosing to better myself and work hard toward selfimprovement/growth. I am motivated to bring my current voice of the unhoused forward, while bring voices of my neighbors forward, with their approval. My unhoused neighbors are dying by my side, some freezing to death, some dying with cancer, some dying with infection...no person in King County should freeze to death outside but tell that to the 5 that have died outside from hypothermia in 2024. I am motivated to see homelessness end. I am motivated to see my brothers and sisters no longer cry from the pain of living outside or the struggles from issues...that tear them apart insideleading to homelessness or the youth telling me how their parents threw them out because they loved "differently", dressed "differently" or felt "differently" then parental expectations allowed (term used by parents) or because they wanted to pursue art instead of a trade, as they pick me up off the ground after falling. Youth with such big hearts that they look out for me...and I never have to ask. Everyone deserves housing! Thats what motivates me.

Candidate #9 - Tamara Bauman

As I've been on the Board for the past 3.5 years, I would relish the opportunity to continue leading the work on incorporating #Wellbeing as a design principle in our system rebid and project evaluation activities. I am motivated by a firm belief that housing is a human right and not a privilege or a commodity! I hope to participate in the redesign of our systems by contributing insights gained from my own lived experience of homelessness and domestic violence as well as my expertise as a service provider. In partnership with the larger community, I hope to actualize a more equitable and effective homeless response system that shares power with those experiencing homelessness and defers to this group of experts when policy decisions are made. Ultimately, I am motivated to see an end to homelessness and the industrialization of this particular humanitarian crisis.
