NOFO Planning Workgroup

- Workgroup of the CoC focused on preparing for the CoC NOFO
- Collectively reviewed all rating criteria
 - Collaborated on recommended changes to the rating and key indicators



FY24 CoC Rating and Ranking

- Rating: scoring projects based on standard criteria (for example, for rapid rehousing how many days it takes to move-in to housing after entering the program).
- Ranking: prioritizing projects based on our local CoC prioritizes
 (for example, historically youth programs have rated low because
 we wanted to prioritize ending youth homelessness we ranked
 lower scoring programs higher to not risk de-funding all youth
 programs).



HUD Requirements for Rating

- 1. Established total points available for each project application type.
- 2. At least **33 percent** of the total points were based on objective criteria for the project application (e.g., cost effectiveness, timely draws, utilization rate, match, leverage), performance data, type of population served.
- 3. At least **20 percent** of the total points were based on system performance criteria for the project application (e.g., exits to permanent housing destinations, retention of permanent housing, length of time homeless, returns to homelessness).
- 4. Provided points for projects that addressed specific severe barriers to housing and services.
- 5. Used data from comparable databases to score projects submitted by victim service providers.
- 6. Provided points for projects based on the degree the projects identified any barriers to participation (e.g., lack of outreach) faced by persons of different races and ethnicities, particularly those over-represented in the local homelessness population, and has taken or will take steps to eliminate the identified barriers.

No Change: HMIS Data

- Rating related to HMIS data did not change.
 - Largely the points related to system performance criteria.



Proposed Changes

- Section 5: HUD / System / Program Component Priority
 Measure
 - Program Component Priority: added additional options
 - Program Population Priority: included Elders and seniors
 - Housing First Narrative: updated criteria and increased point value
 - Program Termination & Low Barrier Housing Narrative: updated criteria and increased point value
 - Participant Engagement/Feedback
 Narrative: updated criteria and increased point value



Proposed Changes Continued

- Section 5: HUD / System / Program Component Priority Measure
 - Lived & Living Experience: updated criteria and increased point value
 - BONUS: Lived & Living Experience: added bonus points
 - Racial Equity Narrative: updated criteria and increased point value
 - BONUS: Racial Equity: added bonus points
 - LGBTQIA2S+ Narrative: updated criteria and increased point value
 - BONUS: LGBTQIA2S+: added bonus points



Proposed Changes Continued

- 6. Project Efficiency and Effectiveness Measure
 - Project Expenditures: updated criteria
