What is Rapid Re-housing?

- Rapid Re-Housing (RRH) is an intervention designed to help households quickly exit homelessness and return to permanent housing.
- RRH enrollment **does not have any preconditions** (such as employment, income, absence of criminal record, or sobriety).
- The program provides tenant-based rental assistance for up to 24 months along with supportive services that are tailored to the unique needs of each household.
- The goals are to help people obtain housing quickly, increase self-sufficiency, and stay housed.

Written Standards - Why?

The King County Regional Homelessness Authority (KCRHA) is updating the Rapid Rehousing (RRH) standards that were previously developed by All Home with input from King County, the City of Seattle, and Building Changes to better align with U.S. Department of Housing and Urban Development (HUD) guidelines.

The standards are what providers refer to when developing or managing a KCRHA-funded RRH program and are referred to in contracts. The drafted standards have been reviewed by the local HUD field office, KCRHA's HUD technical assistant partner - CSH, King County, and the City of Seattle. As part of the Continuum of Care (CoC)-funded programs, these standards must be approved by the CoC Board.



Written Standards - Overview

Accessing RRH in Seattle/King County

- Requirement to use Coordinated Entry
- Parallel system for gender-based violence survivors

Eligibility

- Literal homelessness as defined by HUD
- Documentation requirements

Core Components of RRH

- Housing Identification
- Financial Assistance
- Supportive Services
- 90-Day Reassessments

Policy Requirements

- Rent Subsidy Calculation
- Emergency Transfers
- Termination
- No Contact Procedures
- Grievance

Performance Standards

- Exit Rate to Permanent Housing
- Returns to Homelessness



Timeline

- **January - March 2022**
 - Initial Review: Guideline mapping exercise to review of existing guidelines to understand all funding sources, program guidelines, and what could be changed and by whom.
- **Late 2022 – 2023**
 - Listening Sessions: Engaged with providers and individuals with lived & living experience to gather feedback.
- **Late 2023 - Early 2024**
 - Draft Development: First draft completed, sent for feedback, updated incorporating feedback.
 - New Tools: A custom Income and Rent Calculator was created, based on a model from Los Angeles, with local updates.
- **Late 2024 – Now**
 - Final reviews by KCRHA and Cross Cutting Policy Workgroup



Key Changes

24-Month Assistance

- Extended eligibility for full RRH assistance up to 24 months from previous model of 3-6 months and up to one-year.

Inclusion of Transitional Housing

- Individuals in Transitional Housing are now eligible for RRH as explicitly stated in the standards.

Documentation Standards

- Clearer expectations for required documentation including a zipfile of templates for all documents.

Rental Subsidy Calculation

- Changes to subsidy calculations to align with updated standards.



Feedback and Actions Taken

- **Literal Homelessness Verifications:** KCRHA developed templates for programs to use for these verifications.
- **Rent Reasonableness:** A requirement for all units, with a KCRHA-created template and more detailed guidance for providers.
- **12-Month Leases:** Maintained as standard, with exceptions for certain funding sources.
- **Rent Subsidy Model:** A pilot for the updated Income and Rent Calculator will be introduced with option for programs to develop internal Policies/Procedures should they elect to deviate from recommended model.
- **Exception Requests and Feedback:** Programs are encouraged to submit exception requests, with a feedback form available to collect real-time input.
