2026 Seattle King County Severe Weather RFP

RFP Released: September 18, 2025

Summary of RFP Goals

Guided by [KCRHA's Theory of Change](#), the 2026 Seattle King County Severe Weather Request for Proposals (RFP) sought applications from qualified agencies to provide emergency shelter and support services for individuals experiencing unsheltered homelessness during severe weather events, including extreme cold, excessive heat, and poor air quality.

All proposals were reviewed to ensure completeness, alignment with the program's scope, and budget feasibility. The rating panel recommended funding the proposals that best demonstrated the ability to deliver severe weather response services in at least one of the program areas outlined in the RFP:

- **Shelter Services**
- **Basic Need Provision**
- **Referral & Support Services**

Please note that all awards and contract periods in this announcement are tentative. All obligations to perform or pay funds are contingent upon the execution of a written agreement signed by all required parties.
